

**TOWN OF MILTON
CONDITIONAL USE PERMIT**

Description of Land: Tax Parcel 6-13-88.1, 18.8 acres

Current Zoning of Land: B-1 – Local Business District

Description of Permit: Operation of sport shooting range, including shooting of shotguns, rifles and pistols.

Conditions:

1. Hours of operation will be limited to 8:00 a.m. through 10:00 p.m.
2. The mobile home on the property shall be removed from the property within 6 months of the date of this permit.
3. A safety officer trained in a manner consistent with rules established by the applicant shall be on-site at all times when the shooting range is in operation.
4. The applicant shall create, publish, post and enforce rules appropriate for operation of a sport shooting range.
5. No hunting will be permitted on the property.
6. No projectiles shall be permitted to go beyond the boundaries of the property.
7. The applicant will fully comply with Wis. Stat. § 167.31, relating to safe use and transportation of firearms.
8. No .50 caliber Browning Machine Gun, tracer, or incendiary bullets will be used on-site, and no bullets expressly designed or engineered with the intent of piercing armor plating will be used on-site.
9. No binary (exploding) targets will be used on-site.
10. Only shotguns may be used on trap-shooting ranges.
11. No slugs may be used on trap-shooting ranges.
12. No persons under the influence of alcohol or drugs will be permitted to participate in any shooting activities on the property.

Findings:

In granting this permit, the Town Board makes and adopts the following findings:

1. The property is currently operated as a sport shooting range within the definition set forth in Wis. Stat. §895.527.

2. On the date the sport shooting range on the property was established, it was a lawful use.
3. The sport shooting range existed on June 18, 1998, and on July 16, 2013, as a legal nonconforming use.
4. The applicant's proposed expansion of use of the sport shooting range to include rifle and pistol shooting constitutes an expansion, enhancement or improvement to the sport shooting range within the meaning of Wis. Stat. § 895.527 (4).
5. The applicant's proposed use of the property for shooting shotguns, rifles and pistols may not lawfully be prohibited by the Town except as restricted under the conditions set forth in this permit.

Terms:

1. Violation of any of the conditions enumerated herein shall be deemed a violation of the Zoning Ordinance of the Town of Milton.
2. The several conditions set forth in this Conditional Use Permit are hereby declared to be severable. If any condition of this Conditional Use Permit shall be declared by a decision of a court of competent jurisdiction to be invalid, such decision shall not affect the other conditions.
